Decided to take a pole of who would be interested in attending to make final decision. Commissioner David Ramynke is interested in attending the Bid laws webinar. Needed to check his schedule for Fire service employment webinar, was unsure if he was available. Commissioner David Ramynke and Les Riel would like to see at least the Captains attend the webinars; believe they would really benefit from them both. Commissioner Les Riel will be attending the March 12 Webinar over Fire Service Employment Law.

COMMISSIONER'S REPORT

- a. Commissioner Riel cancelled his executive committee for the county Fire Commissioners, he will send an e-mail out this week notifying everyone the next meeting will be in May.
- b. Chairman Ramynke gave an update on the communications committee; Chief Craig sent an email about a conversation with John Carney (Yakima City ITS Manager) they have developed a way to get some repairs done and notify dispatch of issues.
- c. Chief Hille expressed that the radio noise studently disappeared, Commissioner Riel emphasized wanting to fix communications issues sooner rather than later. Chief advised that dispatch couldn't hear the noise. They had no idea there was a problem in the system till we reached out. Commissioner Les Riel hoping we have a better line of communication now.

ANNOUNCEMENTS

- a. Chief Hille signed the Annual renewal of the DNR contract and returned it.
- b. Chief Hille is sitting in on a Zoom hiring panel for Grant County Fire District 3 for a few hours Wednesday morning. Chief Hille will have Captain Babcock review the Fit Test Grant as it is almost ready for submission.
- c. AD Huitt explained policy revision has started and the Board will start to see them appear in our meetings for review and adoption approval.
- d. Staff evaluations have begun with Chief Hille, paper work is finished but sit downs are to begin shortly. The board would like a summary of the evaluations after they are complete. Chief would like to have all evaluations done by the next executive meeting (2nd week of Feb) and Captain Babcock is also working on the Volunteer staffs as well.
- e. Chairmen Ramynke advised the board is interested in hearing what the staff's career development and succession planning looks like.

- a. There was a backing incident with Engine 42 and it's going to be repaired. A quote for just over \$1000 for a new bumper to be done locally and installed. A new bumper with KME was \$3500. Driver and Officer have been talked to and received verbal warning of which all went into their file.
