Riel made a motion to adopt the updated Resolution 2022-03 Annexing into the Hazard Mitigation Plan with Yakima County. Commissioner Ramynke seconded. Motion carried unanimously.

Resolution 2022-13 Authorization of Investment for 2023

DS Hogan informed the board that resolution 2022-13 allows both Deputy Fire Chief and all board Fire Commissioners to act as the investment officer for the district in her and FC Hille's absence for 2023. Commissioner Ramynke made a motion to adopt Resolution 2022-13 Authorization of Investment for 2023 as submitted. Commissioner Riel seconded. Motion carried unanimously.

NEW BUSINESS

FC Hille had the annual insurance policy reviewed and compared to four different government insurance companies. The company reviewing advised to stay with VFIS. The district's current VFIS insurance policy went up approximately \$4,700 due to call volume and adding new vehicles. FC Hille informed the board that in total our annual insurance policy is about \$37,000 for the year. DS Hogan confirmed that we budgeted a ten percent increase for the 2023 budget which will accommodate the increase.

COMMISSIONER'S REPORT

Commissioner Riel had the WFCA education committee meeting where they set up the spring seminars and the Chelan conference. The Chelan conference will be based on leadership and possibly include Silouan Green. The West and East side series will be split. East side will be a webinar of 5-6 different classes. The West side will be the panel interview where the group will an interaction with the panel on different issues including frequent flyer calls. Commissioner Ramynke asked DC Lamoureux to look at what percentage of our calls are frequent flyers so the board is aware.

ANNOUNCEMENTS - NONE GENERAL DISCUSSION

FC Hille reached out to all lost Volunteers due to covid to see if they would like to come back. Jerry Simmons declined due to his schedule, Kyle Schlotfeldt was interested in coming back, Nick Durand is building a house and is unsure. The rest did not have valid phone numbers anymore. FC Hille also preformed nine recruit interviews all of which seemed like they would make excellent candidates. We will proceed with the onboarding process as normal except for the physical agility. FC Hille and DC Lamoureux are working on a new physical agility test that is relatable to other fire districts for their Volunteer Recruits. Four of the nine applicants already have their EMT and we do not want to lose out on adding Volunteer positions to our department even if they are noncombat positions. Starting January 3rd our combination recruit class with Selah Fire will begin.

FC Hille informed that the Gesa grant for chainsaws should be here any time. During the next meeting we will have final numbers for the year on what amounts we will be transferring into reserves.

Commissioner Riel asked to include appointing the board positions for 2023 in the next meeting on December 27th, 2022.

Commissioner Riel received a call from Charlie Bar from Nile Fire where he use to be a commissioner; Nile fire had a commissioner resign and went to appoint another commissioner of which Charlie Bar applied for but was not invited to said meeting. Commissioner Riel directed him to Rodger Ferris to gather more information on the WFCA protocol and procedures for appointing a Fire Commissioner.

Commissioner Riel stated John Kobli from Highland Fire called and stated George Town is going to resign as a commissioner then be appointed as Highlands Fire Chief. While also giving Chief Widdle his termination papers. They will also be in the process of appointing a Fire Commissioners.

FC informed the new brush truck has arrived and all board members are welcome to test and look over if desired. All crew members will receive an in-service training from Cascade Fire & Safety for each shift. FC Hille review overall expenses stating district cost for the chassis was \$59,491, the budget for the build was \$148,715 additionally increased to \$153,797 due to supply chain issues, additions and price increases. After taxes and licensing the cost was \$226,054 of which \$220,000 was budgeted for it. Budget overage was 3.25%. Additionally. \$5,200 of miscellaneous equipment is going to be installed which is coming out of different line items like PPE. Overall final cost was about \$231,327. FC Hille stated each member will have a minimum of two-hour driver training on the new brush truck before the truck in put in service.

During weekend both Chiefs keep tabs on each other so that coverage is fully taken care of. They will be taken a closer look at what that looks like closer to wildland season.

Commissioner Ramynke asked how he can get ahold of the 2022 WFCA Annual conference classes. FC Hille stated he received the classes and will forward them on.

DC Lamoureux is working on getting a G402 class set up locally in the valley for commissioners instead of at Camp Murry in Tacoma.
