The old Engine 40 will be used as reserve Engine 240. Moved the purchase of an Engine with an Ariel device in 2022. Considering not replacing the rescue vehicle due to the low use rate. Chairman Riel asked the contributions on the Apparatus Schedule match what is on the budget and would like everyone to consider purchasing a Quint within the next year. Lt. Lenseigne will get estimates from both vendors for demos and report back to the Board.
