FC Lamoureux and DS Roberts asked the board if they would like to have a planning meeting in March or if they want to wait until the annual later in the year. The board has made the decision to wait until later in the year.

FC Lamoureux has reached out to 3 different negotiators about contract negotiation but has not heard back from any of them yet. There is one local person that was highly recommended and FC Lamoureux will be reaching out to them tomorrow. Chairman Riel suggested reaching out to Roger Ferris from the WFCA for his list of recommendations.
