b. EVFF Assoc request Annual Awards Banquet Funds Increase from \$35 to \$50 per plate

After discussion the board agreed the banquet would be limited to adults only and denied the request to increase the reimbursement per plate. The district has always paid for the current members and the association pays for the retired members so the amount per plate will not be increased as the district is covering about 75% of the food/incidental costs.

COMMISSIONER'S REPORT

There was discussion at the YCFCA meeting that countywide the communications system needs updating as the City, Sheriff's Office, WSP, and Fire Districts will all be involved and it will likely be a \$10 million project.

MONTHLY EVFD MATTERS

STATION 42 UPDATE

Howard met with structural engineer, plumbing, and electrical consultants on 20 February.

DIRECTOR OF TRAINING

Seven resumes received, six from Washington, one from Florida (recruitment ends 15 March).

COLLECTIVE BARGAINING

Drug testing language still being reviewed and edited; no meeting date scheduled. Should be the last contested issue.

YFD REQUEST TO EXPLORE TRAINING PARTNERSHIP OPTIONS

YFD requested to explore and discuss training partnership possibilities. Could result in station 40 cover during training. Partnership would provide WSRB credit for training tower (until ours is constructed), automatic aid Ladder Truck, and station cover to release EVFD crew for training at tower and in city.

YFD RECRUIT ACADEMY

One EVFD member would like to attend. The 480-hour Academy is Monday through Friday for 12-weeks (01 May through 30 July, graduation ceremony 31 July). Academy includes IFSAC testing for Firefighter I, Firefighter II, and HazMat Operations. I recommend we compensate for attendance: 12-weeks x 40-hours a week x \$12/hour = \$5,760.00. YFD will not charge a registration fee or require a dedicated academy Instructor.
