Commissioner Riel reported that, at the last WFCA Board Meeting, the FF Technical Review Committee discussed a situation where a paramedic crew experienced CO2 poisoning after responding to an emergency call. That crew now has disposable, single-use CO detectors attached to their medic bags that our district might look into as well. The Health Care Committee finished the year 8% under-budget. Wendi Hill was hired as Finance Officer, to start in February. The NB Training Center water treatment plant is operational but they're 18 months out on a new burn tower with replaceable panels. Larry Bartel of Region 8 was named the new Director. Education Committee meetings will be in Spokane February 22nd and in Suquamish April 4th.
