Academy

FC Hille got a notice in the mail today that the classes in October have been canceled but he also was selected to go May 8th - 20th which is all based on strategic planning. Commissioner Riel made a motion to approve FC Hille's Academy trip, commissioner Ramynke seconded. Motion approved unanimously.

FC Hille informed the board that there is an ongoing records request that is almost complete. Emails will have to be printed and scanned back in which will be very time consuming but its in process.

COMMISSIONER'S REPORT

Commissioner Riel informed the commissioners dinner for February at Naches Heights Fire is all set, RSVP will be coming out shortly and the ambulance issue will be a hot topic.

Commissioner Riel attended an executive meeting with WFCA where they approve the agenda for the board meeting and go through all the financials. Then at noon January 22nd the WFCA board meeting was via zoom for an hour.

Commissioner Riel informed that the education committee meeting talked about spring seminar with Brian Snure. He also stated the Chelan conference June 4th will be about personnel problems and litigation that you cannot control.

FC Hille informed the board the he singed the BLM annual agreement.

FC Hille included that the performance evaluations are in process, all captains are finished except FF Andy Babcock for last year as a Cpt. The Cpts will be evaluating the Lt and the Lt are doing FF.

LT Promotional process is also under way, FC Hille has one resume currently in hand and everyone who is applying has till the end of the month to turn theirs in.

GENERAL DISCUSSION

FC Hille sent out a draft of the mission statement from the all call meeting that was discussed. Commissioners are going to review and get back with any changes that they want. Then Chief will send out for final for review.

- New Duty Pickup
- Second Brush Truck Chassis

The department is looking for another Brush Truck chassis because getting them right now is almost impossible per FC Hille. However, the long-range vehicle replacement plan shows in 2023 we are to purchase another Brush Truck and in 2024 the purchase of a new duty truck. FC Hille asked that we purchase a new duty truck now instead of later because with the Deputy Chief of Operations that we are hiring for is provided a vehicle. FC Hille pulled the numbers for the truck its self which runs about \$50,000 and the lighting package another \$15,000. Next meeting FC Hille would like to do an Action Decision Request for the purchase of a new duty pick up which would go through the governor purchase for the state bid process which could take up to 7-10 months. He mentioned that pushing off the purchase of a second brush truck chassis may be beneficial due to not knowing how the current one is going to perform. If there are any issue with this one

once it's put into service that we don't like then we know and can look for different options instead of having two problems.

FC Hille spoke with Nate Craig about West Valleys DS and DS Hogan cross training so that if anything were to happen to either of them then there is a backup for each of the payroll processes. Commissioner Ramynke stated that if WVs new administrative hire is part time we should look into the possibility of seeing if possibly doing part time here would be of interest to acquire full time hours.
