Collyn Stafford

FC Hille informed the board that FF Collyn Stafford has hurt his back and is on LNI for a month; 3 weeks remaining. However, because the district pays him for the first 66 days FC Hille stated he would like to bring him on as light duty to work under FF Robillard. They will be working on the records up stairs to get ready for a bulk shred company to come and dispose of old records that we no longer needed based off of the records retention act. Commissioner Riel would like to be informed as to when the company will be at the station so he can bring old policy books and such to dispose of as well.

Commissioner Riel made a motion to approve drafted policies as submitted 9.01.01 through 09.01.08 as submitted. Commissioner St. Mary seconded. Motion carried unanimously.

#### **COMMISSIONER'S REPORT**

Commissioner Riel attended the WFCA board meeting which included the Health Care usage ratings. The district is currently at 93% for Health Care and Dental is at 101%. He is hoping that if the rates stay where they are that we will get another premium holiday.

Commissioner Riel informed there were a few bills that passed recently. Bill 5155 – Large districts that can perform their own treasurer to be more efficient. Bill 1310 – police reform was reversed so things can go back to the way they were before 1310 was implemented making things a lot safer. Bill 1056 – All districts have to have a website and post board meeting agendas and minutes to it 24 hours in advance, exempt small districts; if it cost more than 1% of budget then they are exempt from having a website. Bill 1329 – allows districts to continue with virtual meetings. Bill 1891 – will allow ranchers/farmers to fight their own fires and districts aren't liable for them doing so. Bill 1921 – allowing grants for smaller fire districts.

Commissioner Riel informed the Vern building construction has started as well as the waste water pond.

Commissioner Ramynke informed that there is a communications committee meeting Wednesday April 27<sup>th</sup> 2022. The Committee wanted to get an extra meeting in before the County Commissioners dinner meeting in May. They will be reviewing capital project money that they were awarded.
