Budget Workshop

The Commissioners, DC Lamouruex and FC Hille agreed the budget workshop will be October 3rd, 2023 at 8:00 am. This will be a special meeting held at Station 40 to go through the 2024 budget, any overtime issues the Department is having and the SAFER Grant. Up until the SAFER Grant is given, FEMA will cover the 10 hours firefighters/EMTs get through FLSA.

COMMISSIONER'S REPORT - None

GENERAL DISCUSSION

ARPA Contract

FC Hille informed the board that he received the American Rescue Plan Act (ARPA) Contract from Yakima County Financial Services Director Craig Warner regarding the grant the state received. FC Hille told everyone that he had emailed Craig Warner about redacting the items in the contract that do not pertain to the department. Craig informed FC Hille that if he were to need to make any changes that our department's contract would be set aside and dealt with after every other department. With this contract being able to allow the department to purchase new thermal imaging cameras, FC Hille agreed to sign.

Overtime

DC Lamouruex informed everyone that he has been working on overtime scenarios including our current situation with injuries, vacations and PFML and how much overtime we can afford to give. So far, we have spent \$260,000 in overtime wages.

Emergency Reporting System

ERS has been purchased by ESO and they are currently increasing the prices claiming some agencies were undercharged. The Chiefs were approached by representatives of ImageTrend and brought it to the boards' attention. This program would allow the Department to buy certain programs individually rather than a one-size-fits-all scenario, there are no inspections and your current programs stay in place. FC Hille also told everyone that ImageTrend has an add on where if the firefighters don't have service while on a call, they can log the information on their tablet and when they are in service again the information will automatically transfer to the ambulance. DC Lamouruex told the board he will take charge on this and look into gaining more information.

Ready Rebound

FC Hille told the board that the Department is currently looking into using a service called Ready Rebound for any injuries that may occur. This program would allow you to call an 800 number that is provided and get connected with a representative that will deal with the Department of Labor and Industries directly that way wait times for doctors' visits, MRIs, surgeries, etc. will be cut in half. The cost would be around \$150/year per career firefighter and covers their families as well.

Service Plagues

Recently the Department had name plates made to place on a service plaque for former Chief Alan Benny and former Fire Commissioner David Ramynke.

Open Commissioners Position

Chairman St. Mary informed everyone that he has an interested individual for the open Commissioners position. Tyler Brandt is the General Manager for the nursery operation at Brandt's Fruit Trees here in Yakima. Tyler has also been involved in the fire service in the past and would like to help out again. The Department will be having a Special BOC Meeting on September 26th, 2023 at 3:00 pm to welcome Tyler to the District.

Solar Farms – Extending the Moratorium

FC Hille told the board that he attended one of the Yakima County Commissioners meetings about the solar farms and extending the moratorium. FC Hille explained there was a lot of misinformation regarding the concerns of fire response in case of fires at the solar farms. FC Hille explained that as long as the solar farms have suppression systems and no flammable vegetation that there are no fire concerns. FC Hille also told the board that most fire suppression systems require you to keep the doors closed in order for them to take effect.
