Fire Chief Dale Hille remains on administrative furlough.

Chairman Riel called the meeting to order at 3:30pm.

Levy Lid Lift

IFC Lamoureux informed everyone that he finished his last meeting regarding the levy lid lift with the East Valley Community Enhancement Association and has had nothing but positive feedback.

Training Facility

IFC Lamoureux informed the board that he received an estimate from SymTech for the sealed drawings at \$23,901, which still keeps the department within the extra \$80,000 allotted from not going with the other bid. Commissioner Brandt made a motion to move forward with the purchase of the sealed drawings from SymTech. Commissioner St. Mary seconded. Motion carried unanimously.

NEW BUSINESS

FY2023 AFG Grant Award Acceptance

IFC Lamoureux informed the board that the department received half of the AFG Grant for a total of \$53,426 but did not receive the other \$56,000 for a new extractor and dryer for Station 42 in Terrace Heights.

District Secretary Contract

The board made a request that there be some revisions made to the District Secretary's contract and brought to the next meeting on August 12th, 2024.

Acceptance of Medical Retirement

After a brief discussion the board made a decision to table the acceptance of Fire Chief Hille's medical retirement at a special meeting where FC Hille can be present.

Appointment of New Fire Chief

The board has also tabled the appointment of the New Fire Chief until there is a final decision made on FC Hille's medical retirement as it could interfere with the Department of Labor and Industries. Commissioner Brandt made a motion to increase IFC Lamoureux's wages to \$135,000 effective immediately and should be dated back to June 8th, 2024 when he took over the Fire Chief's duties. Chairman Riel seconded. Motion carries unanimously.

COMMISSIONER'S REPORT

Chairman Riel informed everyone that there was a data breach in the WFCA and that they are offering security to members. Chairman Riel also informed the board that TPSC will be increasing 3%.

At the next county communications committee meeting Commissioner Brandt informed everyone that they will be discussing the Cowiche Tower and the safety issues that are hindering the timeline for repairs.

GENERAL DISCUSSION

IFC Lamoureux informed the board that in the bid for the new Brush 40 the department included an approval for other departments to use our bid process. IFC Lamoureux was contacted by Pocatello, ID about using our bid process and build to order a brush truck of their own and is asking approval from the board to sign an interlocal agreement.

IFC Lamoureux also informed everyone that the department will have 10-15 new volunteers by the time recruit class starts in January and he is working with firefighters Jack Wutzke and Collyn Stafford on getting uniforms and PPE on order. Chris Foster from the City of Moxee will also be joining the department again as a support volunteer and will be in charge of bringing and manning the air support apparatus to fires when he's available. IFC Lamoureux also informed everyone that the lower valley will be dropping out of the countywide recruit academy as they do not have enough candidates. If any more were to sign up between now and then they will be added to the January class. The department is also looking for what the cost of fire protection will

be per year for the new solar farm that will be built out in no man's land off of Highway 24 by Cypress. IFC Lamoureux is looking to charge \$1,200 and the company had no argument.
