# YAKIMA COUNTY FIRE PROTECTION DISTRICT 4 BOARD OF COMMISSIONERS REGULAR MEETING August 27, 2018

The meeting convened at 4:00 pm at East Valley Fire Station 40. Those present were Commissioner Les Riel, Commissioner David Ramynke, Commissioner Ben St. Mary, Fire Chief Emery and District Secretary Jenifer Huitt. Others present were BC Woodall and SC Lenseigne. Commissioner Ramynke called the meeting to order.

### APPROVAL OF AGENDA

The agenda was approved as amended and the meeting continued.

### SECRETARY'S REPORT

Secretary Huitt noted the prior payroll errors were corrected on 8/17/18. One claim expense was added for boots under Fire claims for Firefighter Equipment \$149.95. PFF Hanson was released to full duty on 9/5/2018 and we are waiting on info from L&I regarding time loss and keeping employees on salary. Chairman Riel made a motion to write up an MOU changing the wording in Policy and Collective Bargaining Agreement stating that if an on-the-job injury occurs the district will keep the employee on salary and work towards the state return to work program with light duty. Seconded and carried.

**a.** ErgoMetrics Proposal for Lieutenants Testing \$8,335

Chief Emery would like to use Ergo Metrics due to their reputation, location, and a history of not being grieved or challenged. Vice Chairman Ramynke made a motion to approve the proposal for ErgoMetrics Testing. Seconded and carried.

**b.** Grant Writing Assistance Proposal \$2000

Chief Emery would like to use Fire Grants Help for the SCBA equipment, up to 75% of the cost can be reimbursed and they have a 60% approval rate. SC Lenseigne said the new engines will have the new equipment on them. Vice Chairman Ramynke made a motion to approve the proposal for \$2000 for Fire Grants Help. Seconded and carried.

c. POC Wages

Chairman Riel proposes we look at using a scale similar to West Valley Fire's to raise the wages for the paid-on-call staff. Vice Chairman Ramynke asked for a budget impact on the proposed changes at a future meeting. The board is all in agreement that Chief Emery draft policy for the proposed paid-on-call wage change.

### COMMISSIONER'S REPORT

Chairman Riel stated the YCFCA dinner meeting at the Nile Fire Department went well and the new station looks great. DNR spoke about the different approach they are using for firefighting.
