# YAKIMA COUNTY FIRE PROTECTION DISTRICT 4 BOARD OF COMMISSIONERS REGULAR MEETING September 24, 2018

### SECRETARY'S REPORT

Secretary Huitt reported the budget position through Aug 31, 2018 is on target with 66% spent and 34% remaining, 2019 WFCA Medical Health Care Rates increased 7.5% to 15%, and a copy of the Chief's drafted Perpetual Planning was provided. Chairman Riel requested a copy of the Health Care sheets from WFCA.

### CORRESPONDENCE

a. Yakima Co Assessor's Office Estimate for 2019 Fire Tax Revenue \$1.7 million Secretary Huitt noted our estimate was received from the county, however it was calculated using last years amount, new construction, and 1% increase instead of the new levy amount of \$1.42 per \$1,000 of assessed value. A corrected estimate was requested and should be about \$2.4 million.

**b.** VFIS Estimate for 2019 Insurance Policies \$33,331

This is 6% more than last year, however it is a best guess as their target premiums have not been released yet for 2019.

c. Review of SunComm's drafted ILA for 2019-2020 and response

Vice Chairman Ramynke would like the last sentence removed from the response. The board was all in agreement that Chief Emery review the ILA, and that any edits be shared with Chief Craig, and the content of the response be shared with all the chiefs at the next meeting.

d. Yakima Co Dept of EMS Estimate for 2019 EMS Tax Revenue \$274,628 Chairman Riel stated the new formula is still being worked on and there will be a transition period to balance out the changes. The county commissioners will have to approve the changes before they are implemented.

### **UNFINISHED BUSINESS**

a. Ward Diesel Filter Systems Estimate for No Smokes on 11 apparatus \$104,012.29 Acting Chief Evers explained that No Smokes is an inline filter/exhaust system that is put on each apparatus and there are no hoses or fans put in the bay. We are looking at surplussing Engine 42 after the new engines are received so that would make 10 apparatus total. The board requested more information from Chief Emery regarding filter replacement scheduling, cost, decreased mileage after installation; which will be addressed at the next meeting.
