Levy Lid Lift

The levy lid lift passed by 63.35% and the next count is on August 16th, 2024. All ballots will be certified on August 20th, 2024.

IFC Lamoureux made the necessary revisions to DS Roberts contract and the board approved and signed.

Appointment of New Fire Chief

The board has made a decision to table the appointment of the new fire chief as FC Hille is currently on L&I leave.

NEW BUSINESS

Policy 05.01.08 – Credit Card Accounts / Revolving Account

Commissioner St. Mary made a motion to approve the revision of policy 05.01.08, the increase of the Comdata card limit of \$10,000 due to the price in fuel increasing. Chairman Riel seconded. Motion carried unanimously.

Policy 01.02.03 – Authority of Board of Fire Commissioners

Commissioner St. Mary made a motion to approved the revision of policy 01.02.03, changing the time of regular BOC meetings from 4:00 pm to 3:30 pm. Chairman Riel seconded. Motion carried unanimously.

• Jeff Burkett - Discussion of Station 40 Annexation into the City of Moxee

City Administrator Jeff Burkett and Contracted City Planner Bill Hordan joined the BOC meeting to discuss the possible annexation of Station 40 into the City of Moxee. The City of Moxee is looking to expand its boundaries due to the Aho homes being built in the area. The Selah / Moxee irrigation district owns the southwest corner of the lot at Station 40 and wants to square it off so that there are no properties left out of the annexation. The City of Moxee Council presented the petition and need 60% of the assessed value to sign. The City of Moxee is also looking for ways to fix the narrow roads in the city due to citizens parking on the sides. City Administrator Burkett has spoken with the City Planners and the developers and expressed that the code is two parking spots per house. The city will be up against the philosophy that the narrow roads help calm traffic, but Jeff Burkett is looking for a comment from the Fie Department to help with the issue due to the engines having a harder time getting through the narrow roads. The board has decided to discuss the issue in the next meeting and possibly add children's safety in the statement.

Resolution 2024-05 Xferring \$55,866.35 from APP to FIRE

Chairman Riel made a motion to approve resolution 2024-05 to transfer \$55,866.35 from Apparatus Reserve to the General Expense fund. Commissioner St. Mary seconded. Motion carried unanimously.

Chief Hille L&I Claim Accepted

DS Roberts informed the board that FC Hille's medical claim was accepted by L&I and he can either medically retire and it won't affect his benefits, or the department can put him on kept on salary. The board will discuss a possible title change if necessary to keep him on his medical benefits through the department.

COMMISSIONER'S REPORT

Chairman Riel informed everyone that there will be an EMS Admin Board meeting on August 14th and another meeting August 16th with Nile-Cliffdell Fire Department at the Woodshed Restaurant. Chairman Riel also mentioned that they're still looking for a Department of Natural Resources representative to speak at the meeting. District 2 County Commissioner Kyle Curtis will also be speaking to ask for endorsement for his upcoming campaign. Chairman Riel and IFC Lamoureux will be attending.

GENERAL DISCUSSION

IFC Lamoureux informed everyone that he has a meeting with the labor union to discuss the proposal of an annexation by the City of Yakima. The board has asked that the department keep our staff in the loop about what is being discussed moving forward.

IFC Lamoureux has designed and ordered a wall clock for the Commissioners meeting room at Station 40 and has been shipped.

A-Shift at Station 40 is working on painting FC Hille's former office to be more up to date for IFC Lamoureux when he is officially appointed Fire Chief.

All of the state mobilization paperwork has been filled out sand turned in for career and volunteers. The department is waiting to finish the career paperwork before starting on the volunteers.

LT. Erickson informed everyone that Engine 240 is back in service. Chairman Riel also requested that the guys look at and try to fix the siren on Engine 44, one of the antique engines at Station 41 in Moxee.
