Chairman Riel made a motion to adopt policy 09.05.04 Response to "No-Man's Land". Commissioner Brandt seconded. Motion carried unanimously.

NEW BUSINESS

• Hiring recommendation of New Deputy Fire Chief

FC Lamoureux informed the board that during the Deputy Chief hiring process there were 4 qualified applicants with one backing out at the last-minute leaving 3 to complete the process. FC Lamoureux would like to recommend hiring YCFD5 Training Captain Chris Munson to be the next Deputy Chief of East Valley Fire Department. FC Lamoureux would like to enter into a contract with Chris Munson as soon as possible and will start working on it with DS Roberts. Chairman Riel would like to have a special meeting on Monday, January 6th, 2025 at 3:00 pm to discuss the contract.

Commissioner Brandt made a motion to approve the hiring of Chris Munson for Deputy Chief. Commissioner St. Mary seconded. Motion carried unanimously.

2025 IAFF 469 Negotiations

FC Lamoureux informed the board that the intent to bargain has been drafted and he will be sending it to the IAFF 469 Local Union and the negotiation attorney.

Lance King – Negotiator Contract

FC Lamoureux informed the board that he has contacted an attorney for negotiations and has received a standard contract stating he will not be charging for travel unless the weather permits him to get a hotel.

Commissioner St. Mary made a motion to accept the negotiation contract from Lance King. Commissioner Brandt seconded. Motion carried unanimously.

ILA YCFD4 2025 – Ladder Truck

Commissioner St. Mary made a motion to approve the Interlocal Agreement with City of Yakima Fire in the mutual use of their ladder truck. Commissioner Brandt seconded. Motion carried unanimously.

 Resolution 2024-16 Xferring \$188,844 from EMS Reserve to APP Reserve Chairman Riel made a motion to approve the xfer of \$188,844 from EMS reserve to Apparatus Reserve. Commissioner Brandt seconded. Motion carried unanimously.

 Resolution 2024-16 Xferring \$150,000 from EMS Reserve to CP Reserve Commissioner St. Mary made a motion to approve the transfer of \$150,000 from EMS Reserve to Capital Projects Reserve. Commissioner Brandt seconded. Motion carried unanimously.

COMMISSIONER'S REPORT - None GENERAL DISCUSSION

FC Lamoureux informed everyone that eh intent to bargain with the Union has been drafted and the attorney, Lance King, will be zooming into the meeting on Monday, January 13th, 2025. FC Lamoureux also informed the board that the department will need to look at comparable pay from other departments. FC Lamoureux is hoping that the department can get through the ground rules and comparable pay in a day. Negotiations will start Friday, January 18th, 2025.

FC Lamoureux ordered a quantitative fit tester for the department and received it. FC Lamoureux also informed everyone that in January there will be a new edition o the tester coming

out but he would like to wait until the company works out any issues it might have before the department looks into purchasing.

The firefighter written test was on Monday, December 16th, 2024 and the department tested a total of 20 applicants after 52 asked for an application. There were 5 volunteer members from the East Valley Fire Department that tested and did not make the top 10. The next step in the career hiring process will be the scenario and interview panel.

Starting January 26th, 2025 FC Lamoureux will be out of the office for the week but will be able to attend the commissioner meeting.
