### **NEW BUSINESS**

#### Use of reader board

FC Hille informed the board that someone from the Mr. East Valley program requested to put something on the reader board advertising the provisions take over. After further discussion, supporting a public restaurant which is a private entity is not allowed. However, FC Hille Stated he would like to support the Mr. East Valley program and the proceeds that are donated to the Children's Miracle Network; because it's a community event. FC Hille stated he would work on putting a policy together.

A list has been put together for him to work on during that time that will be beneficial to the fire district. He will also be able to keep up on his Ongoing Training and Education Program for his EMT certification this way. He will move from shift rates to day rates on a Monday – Friday 8am-5pm Schedule starting Tuesday March 29<sup>th</sup>
