YAKIMA COUNTY FIRE PROTECTION DISTRICT 4 BOARD OF COMMISSIONERS REGULAR MEETING June 24th, 2019

The meeting convened at 4:00 pm at East Valley Fire Station 40. Chairman Riel called the meeting to order and conducted the pledge of allegiance.

APPROVAL OF AGENDA

The agenda was approved as amended and the meeting continued.

SECRETARY'S REPORT

Admin Assistant Martinez explained the reason for the fund transfer in Resolution 2019-03 stating \$16,630.38 was paid on 1/31/2019 from the FIRE fund for the Dispatch Fees that were budgeted from the EMS fund, and \$115.92 was paid on 12/10/2018 from the EMS fund for Payroll that were budgeted from the FIRE fund. So, the difference between the two errors of \$16,514.46 transferring from EMS to FIRE will correct the fund balances.
