# **UNFINISHED BUSINESS**

Amended YCFD5 Dispatch Contract - resigned

FC Hille informed the board that the YCFD5 Dispatch Contract had been updated with a few things the Nile FD & Naches Heights wanted to be included and just needs to be resigned.

• Final Collective Bargaining Agreement Effective January 1, 2022 to December 31, 2025

FC Hille informed the board that the CBA is signed by the union and is up for their approval and signatures. Chairman Ramynke made a motion to approve the New Collective Bargaining Agreement between District 5 and Local 469 effective January 1<sup>st</sup>, 2022 through December 31, 2025 as submitted. Commissioner Riel seconded. Motion Carried unanimously.

FC Hille made a recommendation to hire Fletcher Larson with a start date of January 5<sup>th</sup>, 2022 and Collyn Stafford with a start date of January 4<sup>th</sup> 2022. Commissioner St. Mary made a motion to approve the recommendation to hire of Fletcher Larson & Collyn Stafford with the start date of January 4<sup>th</sup> and January 5<sup>th</sup>. Commissioner Riel seconded. Motion Carried unanimously.

# **NEW BUSINESS**

• Firefighter Garrett Riley Letter of Resignation

FC Hille informed the board that there will be an exit interview for him before he leaves. FF Garrett Riley has asked to have his helmet and has offered to buy it from us. FC Hille would like to make a motion to dispose of the helmet for the least cost to the district and then surplus it. Commission Riel made a motion to accept FF Riley's resignation and also to surplus his helmet. Commissioner St. Mary seconded. Motion Carried unanimously.

Station Dedication Plaques

FC Hille stated the research process for station dedication plaques if done with union gap. FC Hille stated he needs help from the board to figure out what names, pictures etc. need to be included. FC Hille stated the cost will probably range from \$1,500 – \$2,000 a piece once they are complete. Commissioner Riel stated the three board commissioners, Fire Chief, Thomas Cole Pepper was the builder for Station 40 and Station 42 was scout Lake Construction will need to be included. Commissioner Riel informed he would help FC Hille any way he could.

Contract for Reimbursement of Training Expenses – Hiring Document

FC Hille stated that he doesn't find this form completely necessary. Chairman Ramynke stated the district implemented this form because the district pays a stipend after earning certifications and that was the main reason behind it. Commissioner Riel stated he thinks this is an issue for the HR Committee. The Board and FC Hille agreed this will go to the HR Committee.
