Chairman Riel also informed everyone that healthcare increases have taken up 108% of the budget. There is a County Commissioners meeting coming up where the new Fire Marshall will be introduced.

FC Hille informed the board that we have received the Wildfire Ready Neighbors information and flyers to hand out at Yakima Ranches on May 17th, 2024 and other department events. FC Hille also informed everyone that he spoke with a representative at Dozer Days from Bilko Towing and they let us know that if the department ever has a funeral or special event, that they will tow the antique engines to and from the events at no cost. The annual Pancake Feed will be June 9th, 2024 at Station 40. The department has had milk and eggs donated so far, and LT. Erickson informed everyone that he has also secured a refrigeration truck.
