GENERAL DISCUSSION

IFC Lamoureux informed everyone that he and Commissioner Brandt had a meeting with the county regarding the live fire training center on Thursday, June 20th, 2024. After going through

the documents from SymTech again, IFC Lamoureux and Chairman Brandt determined that the training center is in fact defined as a structure not a training prop. IFC Lamoureux had a conversation with John from SymTech and he advised the department that he will be putting together a sealed package of engineering documents to present to Yakima County Permit division to receive the building permits. As of right now, the department does not have an official contract with SymTech that is signed by both parties. Once done through CSD Attorneys, the department is hopeful that SymTech will sign without any changes made to the contract. IFC Lamoureux is determining the ground work to move from December of 2024 to February of 2025.

The department has had a very busy two weeks between two Marsh Rd. brush fires, the Keys Rd. brush fire, Hanford Rd. brush fire, and an RV fire on Moody Rd. IFC Lamoureux informed everyone that on the Keys Rd. fire there were 70 response personnel including the Office of Emergency Management (OEM), and the Department of Natural Resources (DNR). The brush fire ended up going State Mob at around noon on Friday, June 21st, 2024 and IFC Lamoureux will be working on the reimbursement process from the state for the volunteer and career callback response. IFC Lamoureux and Lane Berry from DNR were in command for the entirety of the fire which was from noon on Friday June 21st to 1:00 pm on Sunday, June 23rd, 2024. There were several donations made to the fire including cases of waters and Powerade from Grocery Outlet off of 1st St. in Yakima, boxes of apples from Olympic Fruit in Moxee, 30 pizzas from Dominos off of Union St. in Yakima and snacks and apple juices from Tree Top in Selah. Loftus Labs off of Keys Rd. were also generous enough to let incident command set up their command post in their parking lot. Thank you letters have been written by IFC Lamoureux and mailed out.
