#### **NEW BUSINESS**

 ILA renewal for use of Ladder Truck between City of Yakima and Yakima County Fire District 4 effective now through December 31st, 2024

FC Hille informed the board that the ILA is just an annual renewal the only difference is that they have updated contract payment due to labor management. Every time they have assisted our department it has been on a mutual aid request, which we don't pay for, the only time it's paid is if they are toned out to come to an incident of ours. The ILA helps keep the Survey and rating score low. Commissioner Riel made a motion to approve the ILA renewal for use of Ladder Truck between City of Yakima and Yakima County Fire District 4 as submitted. Commissioner Ramynke seconded. Motion carried unanimously.

#### **COMMISSIONER'S REPORT**

Commissioner Riel will be attending the WFCA education committee meeting December 7<sup>th</sup>, 2022 where the discussion for spring seminars series and Chelan will be held. Commissioner Ramynke asked if NIMS 402 class could be an option for those conferences. Due to the class length of four hours Commissioner Riel advised it would be better for the Annual WFCA conference. DC Lamoureux informed the 402 class is not offered online like the others. He Will be looking into the possibility of hosting the class here in the valley. Commissioner Riel also mentioned the possibility of doing another mock board meeting and to demonstrated the hiring process for Commissioners, Chief, Deputy Chief and District Secretary. FC Hille asked Commissioner Riel to have his board colleague keep us informed on the Covid vaccination front for updates due to the education discussion at the conference lacking information.

### **ANNOUNCEMENTS**

DC Lamoureux informed the board there are seven Volunteer Recruit applicants and interviews are next week, the physical agility test is scheduled for December 10th, 2022 and Recruit classes start the first weekend of January. FC Hille stated we are in the process of updating Job Descriptions to reflect the agreed upon statement for covid vaccinations but we are not asking the volunteers applicants to provide that information.

#### **GENERAL DISCUSSION**

FC Hille stated he will reach out to each volunteer who had left due to vaccination mandate to see if there is any interest in returning to the department.

FC Hille confirmed that Volunteers only need advanced first ad in order to be a volunteer. FC Hille is also still working with West Valley and Selah Fire on sharing volunteers for response numbers.

FC Hille shared that Commissioner LaDon Linde is advertising that there is a fire risk with solar farms. However, after further research on the topic FC Hille came to the conclusion that there really isn't a large fire risk. The goose prairie solar farm will be in our district and the tumble weeds could be an issue. Other than that storage facilities require suppression systems in them and they are made of concrete. A concern for solar panels is when they are removed from a house and bare wires are exposed because they are still producing power and someone could get shocked.
