Chairman Riel called the meeting to order at 3:30pm.

PLEDGE OF ALLEGIANCE

Chairman Riel lead in the pledge of allegiance.

Chairman Riel noted there was no public input at this time.

Hiring of 3 Career Firefighters in 2025

The board and admin staff discussed the hiring of 3 career firefighters in 2025 during the budget retreat and agreed to put it in place after the 1st of March. Commissioner Brandt made a motion to approve hiring 3 firefighters in March of 2025. Commissioner St. Mary seconded. Motion carried unanimously.

NEW BUSINESS

DRAFT Policy 04.01.01 Job Description – District Fire Chief

Chairman Riel made a motion to approve policy 04.01.01. Commissioner Brandt seconded. Motion carried unanimously.

DRAFT Policy 04.01.04 Job Description – Deputy Fire Chief

Chairman Riel made a motion to approve policy 04.01.04. Commissioner Brandt seconded. Motion carried unanimously.

• Union Gap 96B Area

FC Lamoureux informed the board that Union Gap Fire Chief Gregg Cobb approached himself and City of Yakima Deputy Chief DJ Goldsmith about the possibility of annexing the UG parcels in the 96B area into the City of Yakima. As of right now, the UG 96B area is in the East Valley jurisdiction but the department does not respond to calls there. FC Lamoureux also informed the board that DC Goldsmith was supposed to get him more information on the subject and hasn't yet, he is hoping he will have more information by the October 28th, 2024 meeting and is requesting the subject be tabled until then.

2025 FIIRE Program Participation

FC Lamoureux informed the board that this is just a continuation of the agreement and although it is becoming permanent, the department needs to re-enroll. Chairman Les Riel, FC Lamoureux and Lieutenant CJ Erickson will all need to sign. Chairman Riel made a motion to approve the continuation of agreement for the 2025 FIIRE Program. Commissioner Brandt seconded. Motion carried unanimously.

COMMISSIONER'S REPORT

Chairman Riel informed everyone that the Washington Fire Chiefs Association discussed the salary increases for 2025 for staff and the increase will be 4.5%. Chairman Riel also mentioned that the WFCA is talking about the Fire Marshall still being a part of the State Patrol. FC Hille informed everyone he will still be speaking at the WFC Conference next May regarding PTSD.

GENERAL DISCUSSION

FC Lamoureux informed everyone that he and the Selah Fire Chief Jim Lang had a good meeting with the County Commissioners about impact fees in the fire service. FC Lamoureux also had a meeting with City Council member Danny Herrera and said if the County let's fire departments collect impact fees, then it will be county wide.

RC Lamoureux and West Valley Fire Chief Nathan Craig had a meeting with the Washington Surveying & Rating Bureau (WSRB) with Opportunities Industrialization Center (OIC) present since neither were getting any movement from the State Chiefs Association. WSRB has refused to change the staffing requirement since they updated it in 2014.

FC Lamoureux informed the board he has 4 volunteer interviews left to conduct and if all are viable, the department will have 13 recruits starting in January's recruit class. If District 5 decides to join, there will be 18.

The hot dog feed and open house at Station 42 was Saturday October 12th, 2024 and there was a good turn-out. Next year the department will purchase banners from Coca-Cola to hang along Terrace Heights Drive to create more awareness. The department would also like to incorporate a chili cook-off into the hot dog feed and open house for the public to judge.
